Title: Title IX Investigator Training – Part I, II, and III

Purpose:

- Part I – Defining important terms and understanding concepts such as jurisdictions; dismissal of complaints; standard of evidence; when to have an emergency removal; and detailing supportive measures.
- Part II – Defining an informal resolution, exploring the investigative process, and describing the role of the advisor.
- Part III – Observing and examining the live hearing and appeals process.

Purpose: Discussed relevancy of ANSI/ASIS INV.1.-2015 Investigation Standards to Title IX Investigations. Reviewed the investigation process in detail which includes discussing guidelines; necessary competencies for Title IX Investigators; different information types; evaluating data; and preparing conclusions.

Title: Title IX Investigator Training – Part IV

Purpose: Attendees watched six videos and then participated in discussion. Videos show various steps in the Title IX investigation process and are designed to develop investigator interview competency skills; to expand attendees knowledge of the new Title IX process; to promote discussion regarding what went right/what went wrong in the interviews and the process; to assist attendees to determine what could be an interview sequence; to encourage discussion regarding how to ask follow-up questions to determine facts and credibility of the interviewee; and to understand the need for standardization of process of opening/closing an interview by explaining the Title IX process, options for reporting/not reporting, next steps, Supportive Measures, providing handouts, etc.
